Due to Covid-19, The Tax Collector's office is closed to the public.

The following are Frequently asked questions:

Q: IS THE TOWN GIVING THE TAXPAYERS AN EXTENSION ON 4TH QUARTER TAXES?

A: YES, Real Property, Motor Vehicle, Commercial, Tangible property, Sewer use and Sewer Assessment tax bills for **current 4th** quarter have been extended until May 31st with no penalty.

Q: HOW DO I PAY MY TAXES IF THE TOWN IS CLOSED?

A: You may place your payments in the drop box behind the Town building that's labeled Tax Collector Payments.

Please Note: **Personal Checks, Money Orders, Certified Bank Checks ONLY, (PLEASE NO CASH)**

Q: WHERE DO I MAIL MY PAYMENT?

WEST WARWICK TAX COLLECTOR AND IT IS VERY IMPORTANT YOU MAIL THE 4TH QUARTER STUB WITH YOUR PAYMENT TO THE LOCKBOX ADDRESS.

IMPORTANT: IF YOU ARE PAYING WITH AN ONLINE CHECK AND MAILING TO THE LOCKBOX, PLEASE HAVE THE CORRECT ACCOUNT NUMBER WRITTEN ON THE CHECK.

Q: HOW CAN I RECEIVE A RECEIPT OF MY PAYMENT?

A: YOU WILL NEED TO ENCLOSE WITH YOUR PAYMENT A SELF- ADDRESSED STAMPED ENVELOPE AND WE WILL MAIL THE RECEIPT IN THE SELF ADDRESSED STAMPED ENVELOPE YOU HAVE PROVIDED. MAKE CHECKS PAYABLE TO WEST WARWICK TAX COLLECTOR, PLEASE MAIL TO THE ADDRESS BELOW:

Q: CAN I PAY MY TAXES BY CREDIT CARD OVER THE PHONE?

A: NO, YOU MAY PAY ONLINE WITH A CREDIT CARD. **Visa or Mastercard ONLY** – THERE IS A 3 PERCENT CONVENIENCE FEE OF THE TOTAL AMOUNT DUE. GO TO www.RIEGov.com AND LOG IN USING YOUR ACCOUNT NUMBER AND PIN NUMBER WHICH CAN BE FOUND ON THE FRONT OF YOUR TAX BILL.
